Data protection declaration:

The following information provides a simple overview of what happens to people Data happens as soon as you visit our website.

Personal data are all data with which you can be personally identified.

We take the protection of your personal data very seriously and treat your personal data confidentially, or in accordance with the statutory data protection regulations as well of this data protection declaration.

We would like to point out that data transmission over the Internet (e.g. when communicating by e-mail) can have security gaps. A complete protection of the data against access by third parties is not possible.

The data processing on this website is carried out by the website operator. The responsible body is:

'Responsible body' means the natural or legal person who, alone or jointly with others, decides on the purpose and means of processing personal data (e.g. names, email addresses, etc.).

On the one hand, your data is collected when you communicate it to us. This can be, for example, data that you enter in a contact form.

Other data are automatically recorded by our IT systems when you visit the website. This is mainly technical data (e.g. internet browser, operating system or time of the page view). This data is collected automatically as soon as you visit our website

Some of the data is collected to ensure that the website is error-free. Other data can be used to analyze your user behavior.

Many data processing operations are only possible with your express consent. You can revoke your consent at any time. An informal e-mail to us is sufficient. The legality of the data processing carried out until the revocation remains unaffected by the revocation.

If the data processing takes place on the basis of Art. 6 Paragraph 1 lit. e or f GDPR, you have the right at any time for reasons that arise from your special situation to object to the processing of your personal data; this also applies to profiling based on these provisions. The respective legal basis on which processing is based can be found in this data protection declaration.

If you object, we will no longer process your personal data, unless we can prove compelling reasons worthy of protection for the processing that your interests, rights and freedoms predominate or the processing serves to assert, exercise or defend legal claims (objection according to Art. 21 Paragraph 1 GDPR).

If your personal data are processed for direct mail purposes, you have the right to at any time to object to the processing of personal data concerning you for the purpose of such advertising; this also applies to profiling insofar as it is associated with such direct advertising. If you object, your personal data will then no longer be used for direct marketing purposes (objection in accordance with Art. 21 Paragraph 2 GDPR).

You have the right to receive information about the origin, recipient and purpose of your stored personal data. You can also request that this data be blocked or deleted. You can contact us at any time at the address given in the legal notice if you have any further questions on the subject of data protection. You also have the right to lodge a complaint with the competent supervisory authority.

You also have the right, under certain circumstances, to request that the processing of your personal data be restricted (for contact details, see imprint). The right to restrict processing exists in the following cases:

- If you dispute the accuracy of your personal data stored by us, we usually need time to check this. For the duration of the test, you have the right to request that the processing of your personal data be restricted.
- If the processing of your personal data was / is unlawful, you can request the restriction of data processing instead of deletion. You no longer need your personal data, but you need them to exercise, defend or assert legal claims, you have the right to request that the processing of your personal data be restricted instead of deletion. 1 GDPR, a balance must be made between your and our interests. As long as it is not yet clear whose interests prevail, you have the right to request that the processing of your personal data be restricted.

If you have restricted the processing of your personal data, this data may only be used with your Consent or to assert, exercise or defend legal claims or to protect the rights of another natural or legal person or for reasons of an important public interest of the European Union or a member state.

In the event of violations of the GDPR, the Affected parties have the right to lodge a complaint with a supervisory authority, in particular in the member state of their habitual residence, their place of work or the place of the alleged violation. The right to lodge a complaint exists without prejudice to other administrative or judicial remedies.

You have the right to have data that we process automatically on the basis of your consent or in fulfillment of a contract handed over to you or to a third party in a common, machine-readable format. If you request the direct transfer of the data to another person responsible, this will only be done if it is technically feasible. Send site operators, an SSL or TLS encryption. You can recognize an encrypted connection by the fact that the address line of the browser changes from "http: //" to "https: //" and by the lock symbol in your browser line. If the SSL or TLS encryption is activated, the data that you transmit to us cannot be read by third parties.

Some websites use so-called cookies. Cookies do not damage your computer and do not contain viruses. Cookies serve to make an offer more user-friendly, more effective and safer. Cookies are small text files that are stored on your computer and saved by your browser.

Most cookies are so-called "session cookies". They are automatically deleted after your visit.

Cookies that are required to carry out the electronic communication process or to provide certain functions you require (e.g. shopping cart function) are stored on the basis of Art. 6 Para. 1 lit f GDPR.

The website operator has a legitimate interest in storing cookies for the technically error-free and optimized provision of its services. If other cookies (e.g. cookies for analyzing your surfing behavior) are stored, these are treated separately in this data protection declaration.

The provider of the pages automatically collects and saves information in so-called server log files, which your browser automatically sends to us transmitted. These are in detail:

We do not pass on this data without your consent.

The data entered in the contact form is therefore processed exclusively on the basis of your consent (Art. 6 Para. 1 lit. a GDPR).

You can revoke this consent at any time. An informal e-mail to us is sufficient. The legality of the data processing operations carried out until the revocation remains unaffected by the revocation.

The data you enter in the contact form will remain with us until you ask us to delete it, revoke your consent to storage or the purpose for data storage no longer applies (e.g. after processing has been completed Your request). Mandatory legal provisions - in particular retention periods - remain unaffected.

If you contact us by e-mail, telephone or fax, your request, including all personal data resulting from it (name, request), will be stored by us for the purpose of processing your request and processed. We do not pass on this data without your consent.

This data is processed on the basis of Art. 6 Para. 1 lit. b GDPR, provided that your request is related to the performance of a contract or is necessary to carry out pre-contractual measures.

In all other cases, the processing is based on your consent (Art. 6 Para. 1 lit. a GDPR) and / or on our legitimate interests (Art. 6 Para. 1 lit.f GDPR), as we have a legitimate interest in the effective Processing of the inquiries addressed to us.

We collect, process and use personal data only insofar as they are necessary for the establishment, content design or change of the legal relationship (inventory data). This is done on the basis of Art. 6 Para. 1 lit. b GDPR, which allows the processing of data for the fulfillment of a contract or pre-contractual measures.

We only collect, process and use personal data on the use of our website (usage data) as far as this is necessary to enable the user to use the service.

We collect, process and use personal data on the use of our website (usage data) only insofar as this is necessary to enable the user to use the service or to bill Business relationship deleted. Statutory retention periods remain unaffected.
